BRITISH AEROSPACE INDUSTRY: LETTER FROM KENNETH WARREN MP



Kenneth Warren has told me of your interest and support of the SBAC efforts in endeavouring to set up trading opportunities with Soviet Russia. Due to your initiative with Mr. Gorbachev we were able to arrange a visit to Moscow last week and had encouraging talks with the Ministry of Aviation Industry.

As a result a number of areas for co-operation have been identified which we hope will eventually lead to firm proposals for Joint Ventures in the Civil Aviation Market.

We were courteously received by Sir Roderic Braithwaite who we debriefed on our discussions with the Russians.
